ORDINANCE NO. 2008-04

AN ORDINANCE AMENDING ORDINANCE NO. 2007-02, ENTITLED
 BUSINESS LICENSE CODE OF THE TOWN OF COLLINSVILLE, ALABAMA

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF COLLINSVILLE,
 ALABAMA, AS FOLLOWS:

SECTION 1. The specific classifications and portions of Section 22, License Classification Code, of the Business License Code of the Town of Collinsville, Alabama, Ordinance Number 2007-02 set out and listed by title letter below shall be, and are hereby amended and replaced with the following language, effective for the calendar year 2008 and following years unless and until otherwise amended:

AMEND SECTION 22: License Classification Codes.

SECTION 2. Effective Date.

This ordinance shall become effective April 12, 2008.

SECTION 3. Severability. The sections, paragraphs, sentences, and phrases of this ordinance are severable, and if any sections, paragraphs, sentences, and phrase of this ordinance shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other part.

SECTION 4. Repealer. All ordinances in conflict with the provisions of this ordinance are hereby repealed.
