ORDINANCE NO: 2019-02

AN ORDINANCE TO FURTHER AMEND ORDINANCE 2010-05 – ALCOHOLIC BEVERAGE ORDINANCE AND THE AMENDED AMENDMENT TO SAID ORDINANCE 2010-06 TO ALLOW SUNDAY SALES OF ALCOHOLIC BEVERAGES WITHIN THE CORPORATE LIMITS OF THE TOWN OF COLLINSVILLE, ALABAMA

BE IT ORDAINED by the Town Council of Collinsville, Alabama, that Ordinance No: 2010-05 and the Amendment to that Ordinance No: 2010-06 is hereby further amended as follows:

Section 1: Authorized Hours Off Premises Sales and Consumption.

There shall be no prohibited hours for any person, whether a liquor, wine or beer license to sell, offer for sale or to serve, dispense for reward, any liquor, wine or beer or to allow the consumption of any alcoholic beverages for off premises consumption.

On Premises Consumption. The sale, serving, dispensing of any liquor, beer or wine on the licensed premises of any cafe, restaurant or other location holding a license granted by the Alabama Alcoholic Beverage Control Board shall not be lawful between the hours of 2:00 a.m. Until 12 Noon on Sunday of each week.

Authority: This Ordinance is amended pursuant to the authority granted wet municipalities under Act No: 2019-100, Acts of Alabama, 2019. Said act having been approved by the Governor on May 5, 2019 and having become effective on the first day of the third month following its passage and approval by the Governor.

Section 2 : All other parts, provisions, paragraphs of the foregoing ordinance shall not be effected by this Amendment.

Section 3: This ordinance shall become effective upon its adoption, approval and publication as required by law.
