ORDINANCE NO. 2021-03

AMENDING ORDINANCE NO. 2009-07 OF THE TOWN OF COLLINSVILLE  
WHICH PROVIDES FOR THE COLLECTION, HAULING, AND DISPOSAL OF  
SOLID WASTE AND FEES THEREFORE

IT IS HEREBY ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE  
TOWN OF COLLINSVILLE AS THE GOVERNING BODY OF THE TOWN OF  
COLLINSVILLE, ALABAMA, AS FOLLOWS:

SECTION 1. To amend Section 2-2. Applicability, to read as follows:

SECTION 2-2. Applicability. Provisions of this Ordinance shall apply to all premises located within the corporate limits and police jurisdiction of the Town of Collinsville and the Town of Collinsville may provide solid waste collection services in unincorporated areas of Dekalb, and Cherokee Counties in accordance with the provisions of Section 22-27-3(4), Code of Alabama, 1975, as amended, with written consent of the appropriate county commission.

SECTION 2. To amend Section 8-3-1 (a). Fees, to read as follows:

SECTION 8-3-1. Fees

8-3-1 Beginning with the services to be rendered for the period commencing September 1, 2021, and for each calendar month thereafter, the following mandatory monthly fees will be charged:

(a) Basic Service:

**(1) Residential Rate: For each single-family dwelling unit will be provided a container of 95 gallons and there shall be a mandatory minimum charge of \$15.00.**

**(2) Senior Rate: For each non-commercial customer over the age of sixty-five (65) not utilizing more than one approved container of 95 gallons and there shall be a mandatory minimum charge of \$10.00.**

**(3) Housing Authority Rate: For each single-family dwelling unit not utilizing more than one approved container of 95 gallons and there shall be a mandatory minimum charge of \$10.00.**

**(4) Commercial Rate: For each commercial establishment not utilizing more than one approved container of 95 gallons and there shall be a mandatory minimum charge of \$15.00.**

- (b) Basic Dumpster Service: Customers located inside the town limits or police jurisdiction of Collinsville - 8 Yard Dumpster \$75.00  
6 Yard Dumpster \$60.00

Basic Dumpster Service: Customers located in unincorporated areas of Cherokee, and Dekalb Counties –

8 Yard Dumpster \$150.00

6 Yard Dumpster \$ 90.00

- (c) Collinsville Health Care & Rehab Rate: \$150.00 (one weekly collection)

8-3-2 Beginning with the services to be rendered for the period commencing October 1, 2009 and for each calendar month thereafter, the following mandatory monthly fees will be charged for additional scheduled services:

- (a) Collection and disposal of the contents of more than one (1) approved containers in conjunction with Basic Service, Residential Rate:  
Customers located inside town limits and police jurisdiction –  
\$10.00 per month per container.

Customers located in unincorporated areas of Cherokee, and Dekalb Counties- \$10.00 per month per container.

- b) Collection and disposal of the contents of more than one (1) approved containers in conjunction with Basic Service, Commercial Rate:  
Customers located inside town limits and police jurisdiction –  
\$10.00 per month per container.  
Customers located in unincorporated areas of Cherokee, and Dekalb Counties - \$10.00 per month per container.

- (c) Additional scheduled collections in conjunction with Basic Dumpster Service: Customers located inside town limits and police jurisdiction-  
8 Yard Dumpster - \$75.00 per month per additional weekly collection.  
6 Yard Dumpster - \$60.00 per month per additional weekly collection.

Customers located in unincorporated areas of Cherokee, and Dekalb Counties –

8 Yard Dumpster \$150.00 per month per additional weekly collection.


6 Yard Dumpster \$ 90.00 per month per additional weekly collection.

- (d) Additional scheduled collections in conjunction with Collinsville Health Care and Rehab: \$150.00 per month per additional weekly collection.

SECTION 2. All other parts, provisions, sections, paragraphs of Ordinance 2009-07 shall remain in full force and affect and shall not be otherwise affected by this amendment.

SECTION 4. This amendment shall be in full force after its passage by the Mayor and Town Council of the Town of Collinsville Alabama, and upon publication as required by law.
